5. Types of Information Collected

We retain the following information types:

- 5.1 Personal Data: This is data that identifies you or can be used to identify or contact you and may include your name, address, email address, user IP addresses in circumstances where they have not been deleted, clipped or rendered anonymous, telephone number, and billing and credit card information. Such information is only collected from you if you voluntarily submit it to us.
- 5.2 Non-Personal Data: Like most web sites, we gather statistical and other analytical information collected on an aggregate basis of all visitors to our web site. This Non-Personal Data comprises information that cannot be used to identify or contact you, such as demographic information regarding, for example, user IP addresses where they have been clipped or rendered anonymous, browser types and other anonymous statistical data involving the use of our web site.
- 6. Purposes for which we hold your information

You will be notified in the event of any such transfer and you will be afforded an opportunity to opt-out.
